### A MESSAGE FROM THE 2023-2024 CHAIR



As I reflect on my service as the Chair of the 2023-2024 Board of Directors for Houston Volunteer Lawyers, I am proud of the work that was accomplished and the advancement of our mission to provide equal access to justice for all.

Overall, HVL provided legal assistance to more than 5,300 clients. This includes thousands of hours of pro bono hours provided by 1,009 private attorneys who volunteered their time and expertise to provide legal advice to 88% of these clients and extended representation to the rest. Legal issues included landlord/tenant concerns, estate planning, guardianship, expungement and record sealing, probate, and more. HVL continued to serve our veterans with volunteer attorneys meeting every Friday at the VA Hospital to provide in-person legal assistance.

And, with funds provided by the Equal Justice Works Foundation, HVL hired a full-time immigration attorney in late 2023 who hit the ground running. New community partnerships were created, and three naturalization clinics were hosted within the first half of 2024 with more planned going forward.

As I began my year as Chair, I hoped more attorneys would make time to support HVL and dedicate time during the year to volunteer. I want to thank the seven firms who hosted New Associate Boot Camps in the fall. This outward demonstration to new attorneys of making pro bono service an important part of a legal career set a wonderful tone to so many young attorneys who were just getting started.

Another example of the importance of pro bono volunteerism are the eight firms who worked with HVL to create projects for their summer associates. Many of these summer projects allowed the two- and three-year students who may have been working in a law environment for the first time to work with an experienced attorney at the firm on meaningful work that helped advance equal access to justice.

HVL was excited to establish a new Medical-Legal Partnership with AccessHealth, a federally qualified healthcare provider that serves clients in Fort Bend and Waller Counties. Extending HVL's presence into the counties surrounding Harris County broadens our reach to more clients and includes volunteer opportunities for attorneys who practice outside of Houston.

The merger of the Houston Bar Association's Legal Hotline into HVL's Legal Advice Clinics capped off many months of planning and coordination. The newly created HBA LegalLine Powered by HVL and Consejos Legales expanded the provision of legal advice to additional days and hours during the week, better serving both the clients and the volunteer attorneys.

The year flew by as the HVL Board and staff, joined by hundreds of volunteers, worked tirelessly to meet the challenge of bridging the legal gap that exists for thousands of our low-income neighbors. Thank you for the opportunity to lead this organization as together, we did the work to provide equal access to justice for all.

## A MESSAGE FROM THE EXECUTIVE DIRECTOR



My first year as Executive Director of Houston Volunteer Lawyers was filled with meeting new people – staff, Board Members, attorney volunteers, community partners, clients, and funders. With everyone working together, HVL grew to serve more clients, to offer additional legal services, to build new community partnerships, to involve more attorneys, and to receive financial support from new funders, all while maintaining strong relationships with those who have been a part of HVL for years.

With the groundwork laid as the year began, the theme of the 23-24 year was to "Dig In and Get to Work". Internally, the HVL staff was reorganized so that the needs of the community were matched with the volunteer spirit of our pro bono attorneys. The weekly Veterans Legal Clinics drew more and more veterans to the VA Hospital on Friday afternoons seeking legal assistance and the number of attorneys who volunteered every Friday afternoon kept pace.

HVL built upon the partnership with the Houston Public Defender's Office to continue to provide legal assistance for graduates of the Fresh Start program to expunge and seal past criminal records to remove barriers faced by those who had paid their debt to society.

New partnerships were created with community partners including Community Family Centers as HVL rolled out legal assistance for those eligible for naturalization to become U.S. citizens. Supporting this entry into immigration assistance were the Equal Access to Justice Foundation and Houston Endowment that provided the funding necessary to implement this new program. HVL was also thrilled to partner with AccessHealth, a federally qualified healthcare provider, to create a Medical-Legal Partnership for clients in Fort Bend and Waller counties. By committing to the expanded geographic area served by HVL, we reached more clients and offered volunteer opportunities for additional attorneys who primarily practice in those jurisdictions.

On a personal note, I want to thank the Board of Directors and staff for stepping in as my family grew when my second son was born in October. A special thanks to Greg Moore, the Board Chair, and the four directors at HVL, all of whom kept the pace steady while I was out on parental leave.

Upon my return, the new immigration attorney had been hired and had already set dates for the 2024 naturalization clinics at which dozens of lawful permanent residents received assistance in completing their applications for citizenships. HVL plans to assist 200 individuals apply for and become citizens of the United States before the end of 2024.

The momentum continues as the 23-24 Board of Directors ended their terms of office. I thank all those who were a part of the success of the 23-24 year and invite you to join us, if you aren't already working with HVL, as we continue to develop programs that will reach more clients in our vision to provide equal access to justice for all.

# BRIDGING the legal gap

The mission of Houston Volunteer Lawyers is to promote **access to justice** for individuals in the Houston area by assisting those who cannot afford legal representation in **civil matters.** 

What does it mean to have equal access to justice for all?

At HVL, we believe that the ability to afford an attorney should **NOT** determine who has access to justice. There is **NO** constitutional right to an attorney in civil matters, leaving multitudes of our neighbors on their own when facing civil legal issues. Trying to navigate the legal system on your own can be incredibly challenging.

#### And Civil Matters Matter

Civil laws exist to secure and protect basic needs, including housing, education, healthcare, income, and safety. These are the areas of the law that most of us will encounter at some point in our lives. Having an attorney on your side when dealing with civil matters makes a huge difference.



## ADVANCING our micco

#### Connecting those in need of legal assistance with volunteer lawyers

Between July 1, 2023 and June 30, 2024, more than 5,000 individuals received free legal assistance thanks to 1,000 private attorneys who donated their time and shared their legal expertise. In total, these pro bono attorneys provided advice and counsel to 4,500+ individuals and represented another 700+ in their legal matters. And, the volunteer attorney often received as much as or more than they gave.

In the fall of 2023, HVL introduced a Boot Camp for new associates who joined various law firms. ## ADVANCING our mice

#### Working in the community through strategic partnerships to provide legal information, education, and support

In the greater Houston area, there are hundreds of thousands of individuals who will face at least one civil legal issue each year and will not have the funds to hire an attorney. Finding those individuals, informing them of HVL's services, and developing the level of trust necessary for legal assistance to be beneficial depends on building and maintaining strategic relationships with community partners that provide other vital services to these same individuals.

In 2023 -2024, HVL continued to partner with Memorial Assistance Ministries, BakerRipley Neighborhood Centers, Texas Children's Hospital, Michael E. DeBakey VA Medical Center, Dress for Success, South Texas College of Law, University of Houston Law Center, Thurgood Marshall Law School, the City of Houston, Harris County Attorney's Office, Public Defender's Office, Communities in Schools, and Spring Branch Family Development Center.



HVL also added some new community organizations as strategic partners in 2023-2024. AccessHealth joined HVL in a Medical-Legal Partnership serving the residents of Fort Bend and Waller Counties. Community Family Centers stepped up in a big way to partner with HVL to offer legal assistance for naturalization applications for their clients including providing community members who had graduated from a Spanish interpretation class. HVL is also thrilled to be working with the Harris County Probate Courts, HISD's Sunrise Centers, Bear Creek Masjid, Mi Familia en Accion, Engage, Third Ward Multiservice Center, and Sunnyside Multiservice Center.











## PRO BONO ATTORNEYS M

HVL is the largest provider of pro bono legal services in Texas. Maintaining a pro bono model of service delivery requires a balance of clients who need assistance with a variety of legal issues that match the capacity of private attorneys who find time to volunteer their legal expertise often in areas of the law that are other than what their daily practice involves.

Private attorneys who make time in their schedules to assist HVL clients who otherwise would not have access to an attorney are local heroes. HVL encourages attorneys to volunteer, supports each attorney when needed, and monitors the progress of each case.

#### **Recruit More Boots Challenge**

In 2024, HVL introduced the Sales *Recruit More Boots Challenge*. James B. Sales initiated and founded HVL over 40 years ago. He was often heard saying, "We need more boots on the ground" in the fight to provide low-income Texas with access to legal representation. Mr. Sales died in 2023, but his spirit will live on each year as HVL hosts the *Recruit More Boots Challenge*. HVL thanks the thirty attorneys who participated in the inaugural *Recruit More Boots Challenge*.

#### Pro Bono Coordinators Toolkit

Some of the unsung heroes of providing pro bono legal assistance to clients are the Pro Bono Coordinators who work at law firms and serve as the HVL contacts, cheerleaders, pro bono promoters, and more. To support their efforts to encourage their colleagues to volunteer, HVL introduced the Pro Bono Coordinators Toolkit. Ready to use email blasts, pro bono month celebrations, pro bono opportunities, and more are just a click away for the busy Pro Bono Coordinator.

#### Nurturing the Next Generation of Advocates

Introducing Pro Bono volunteerism to law students and new attorneys is a way to encourage those just starting out on their legal career path to make sure to make time for pro bono service throughout their careers.

New Associate Boot Camps – We sincerely thank the law firms that participated in our inaugural New Associate Boot Camp, where 100% of their new associates took on their first pro bono cases. ### EQUAL ACCESS TO JUSTICE CHAMPIONS

And, that 55% of those report that the civil legal problem substantially impacted their lives – with the consequences affecting their finances, mental health, physical health and safety, and relationships."

The Justice Gap: The Unmet Civil Legal Needs of Low-Income Americans, Legal Services Corporation, 2022.

In the greater Houston area, this means that 800,000+ residents face a civil legal matter each year. Most will be on their own to navigate the justice system and will face numerous barriers in their attempts to receive equal access to justice.

Houston Volunteer Lawyers along with hundreds of pro bono attorneys work each day to offer innovative ways to help meet as many of these needs as possible.

#### HBA LegalLine Powered by HVL

A merger between HBA's LegalLine and HVL was completed this year. The result is that clients now have additional days and hours during which they may receive legal advice and counsel from a pro bono attorney. Additionally, Spanish speaking attorneys offer Consejos Legales once a month for those clients who speak Spanish.

#### **Naturalization**

HVL was awarded funding by the Equal Justice Works Foundation and Houston Endowment to add legal assistance for eligible lawful permanent residents to apply for citizenship through naturalization. Pro bono attorneys stepped up to assist, new community partners joined this effort, and dozens of clients attended Saturday clinics to receive legal assistance.

## FUNDING PARTNERS matter

Appearing before Congress, Legal Services Corporation President Ronald S. Flagg, noted that "the current federal appropriation for legal aid is far less than the \$700 million a year that Americans annually spend on Halloween costumes.....for their pets."

Even with the generous in-kind donations of the time and expertise of the hundreds of private attorneys who provide pro bono legal services, funding partners are critical to HVL's ability to continue this work. #### Medical-Legal Partnership Launched in 2024

AccessHealth, a federally qualified healthcare provider, contracted with HVL to work collaboratively with the health care clinics to identify and assist patients with legal issues that cause or exacerbate their medical needs. An HVL staff attorney is available for patients at any of the 4 AccessHealth clinics in Fort Bend and Waller counties.

After a thorough study of the immigration needs best matched to Houston Volunteer Lawyers' pro bono model of service, funding was sought to begin offering legal assistance for naturalization applications. HVL thanks Equal Justice Works, Houston Endowment, and the Give Citizenship a Boost fund from the Houston Immigration Legal Services Collaborative for joining forces to provide the funding necessary to add this area of legal assistance to the menu of services provided to eligible area residents.

#### Night Court

For many years, HVL has been a recipient of the funds raised by the annual Night Court show – an original musical comedy produced by a cast of attorneys in the Houston area. The 2023 Night Court show – The Law Files – resulted in a generous donation and included an HVL attorney in the cast.

### A MESSAGE FROM THE 2023-2024 HOUSTON BAR FOUNDATION CHAIR

The Houston Bar Foundation was established in 1982 as the charitable arm of the Houston Bar Association. HBF's mission is to support programs that help provide legal representation to the indigent, promote community understanding of our legal system, and foster the administration of justice.

Through the generosity of our contributors and supporters of the annual Harvest Celebration hosted by the Houston Bar Association, HBF is proud to be a major funder of Houston Volunteer Lawyers. The three-way relationship between HBF, HBA, and HVL allows each organization to provide their own unique strengths to maintain a strong commitment to providing equal justice for all.



A successful pro bono model of service delivery depends on the host organization, HVL, to identify applicants, determine eligibility for each, conduct an initial interview with each applicant, schedule and host weekly remote and in-person clinics, provide legal information and resources to the pro bono attorney for each client, be available for ongoing mentorship over the life of each case, and a million other tiny details that make the volunteer experience a good one.

Volunteers are critical to a successful pro bono model of service delivery and those volunteers come mainly from the membership of the HBA. In the 2023 audit of HVL's services, more than \$14 million of donated services were documented thanks to the generosity of hundreds of private attorneys, law firms, corporate law departments, and solo practitioners.

The Houston Bar Foundation's annual financial support of HVL provides almost one-third of their entire budget. Especially important is that HBF's funding, unlike most of HVL's other funding, is unrestricted. Thanks to HBF, legal services can be provided free to individuals regardless of their immigration status. Veterans and their dependents are eligible no matter their discharge status or time of service. HBF funds also make sure that even if one funding source ends, the clients that were being served through it can continue to receive legal assistance until their issue has resolved.

Just like a three-legged stool, each partner is equally critical to offering and maintaining free legal assistance delivered by volunteer attorneys who are HBA members, managed by HVL, and funded by HBF. Together we strive to serve those most vulnerable and in greatest need in our community. This partnership results in a daily commitment to providing equal access to justice for all.

### A MESSAGE FROM THE 2023-2024 HOUSTON BAR ASSOCIATION PRESIDENT

The Houston Bar Association is one of the largest metropolitan bar associations in the nation. With a membership of more than 11,000 members, HBA members have hundreds of opportunities to expand their legal knowledge through professional development programs, grow their networks through committee and section involvement, and volunteer their time to support good causes in partnership with dozens of local charitable organizations. One especially rewarding volunteer opportunity that hundreds of HBA members choose each year is to provide legal assistance to the clients served by our partner organization, Houston Volunteer Lawyers.



During my year as HBA President, 1,009 attorneys donated 22,277 number of hours providing advice and counsel and

offering full representation to more than 5,000 clients who otherwise would not have legal assistance with their matters. At any given time, HBA members are working with 1,000 HVL clients on issues including expungement, record clearing, estate planning, probate, IRS tax disputes, evictions, name change, guardianship of a disabled child upon reaching adulthood, custody, divorce, adoption, veteran discharge upgrades, and many more.

This past year, we expanded HVL's menu of services to offer legal assistance for Green Card holders who may be eligible to apply for U.S. citizenship through naturalization. Our bar members responded to this expansion with much excitement, and as a result, many bar members volunteered for the first time with HVL. It is an incredibly rewarding experience to help individuals through the citizenship process, and we encourage bar members to attend their HVL clients' Oath Ceremony, which is momentous for both the client and the attorney.

The beauty of HBA is that with its long history and the ongoing commitment of the membership, even when things change, the work goes on. In the spring of 2024, the HBA Executive Director, Mindy Davidson, retired after a 30-year law career and having served the HBA in the Executive Director position since 2019. The HBA welcomed Vinh Ho as our new Executive Director. Vinh, a frequent HVL volunteer, brings many talents to the role of Executive Director.




Money matters. Volunteer time matters. Pro Bono attorneys matter. Pro Bono attorneys turn one dollar into \$5.17.
